A Japanese Grant of US\$ 76,100 for the Project for Renewal of Ultrasound Equipment for Health Clinics


The Government of Japan has decided to extend a grant of seventy six thousand one hundred US dollars (US\$ 76,100) to an NGO named The Jordanian Association for Family Planning and Protection (JAFPP) for the renewal of ultrasound equipment under the scheme called Grant Assistance for Grass-roots Human Security Projects (GGP).

A Grant Contract was signed on September 18th, 2018 by H.E. Mr. Hidenao Yanagi, Ambassador of Japan to the Hashemite Kingdom of Jordan and Dr. Abed Mansi, the chairman of board of directors of JAFPP.

This grant assistance aims to improve the performance of gynaecological examination provided at JAFPP's health clinics, through the provision of new ultrasound equipment. JAFPP was established in 1964 as an NGO and has been supporting vulnerable mothers and babies by providing medical services at a minimal price, in addition to extending various kinds of supports such as counselling and awareness programs. With the new medical equipment provided by Japan, more accurate and immediate diagnosis by the doctors and the required treatment afterwards will be available.

At the signing ceremony, Ambassador Yanagi expressed his gratitude to JAFPP's great contribution to the society and stated: "The Government of Japan understands that it is considered as a basic human right for all mothers and babies to receive necessary support regardless of their social background; therefore it is very important to secure the opportunity for the needed medical care at affordable price in the course of pregnancy."

A Japanese Grant of US\$ 72,933 for the Project for Provision of Medical Equipment to Medical Center in Jerash Palestinian Refugee Camp


The Government of Japan has decided to extend a grant of seventy two thousand nine hundred and thirty three US dollars (US\$ 72,933) to an NGO named Jordan Medical Aid for Palestinians (JMAP) for the provision of medical equipment under the scheme called Grant Assistance for Grass-roots Human Security Projects (GGP).

A Grant Contract was signed on September 19th, 2018 by H.E. Mr. Hidenao Yanagi, Ambassador of Japan to the Hashemite Kingdom of Jordan and Mr. Munib Al Masri, the president of the board of trustees of JMAP.

This grant assistance aims to improve the quality of medical services provided at JMAP's medical center, through the provision of medical equipment such as X-ray unit, cardiology ultrasound, ECG and ENT unit. JMAP was established in 1990 as an NGO and has been supporting Palestinian refugees and other vulnerable people by providing needed medical services. With the new medical equipment provided by Japan, more accurate and immediate diagnosis and the required treatment afterwards will be available.

A Japanese Grant of US\$ 87,319 for the Project for Equipping Hearing and Visual Clinic in Azraq Syrian Refugee Camp


The Government of Japan has decided to extend a grant of eighty-seven thousand three hundred and nineteen US dollars (US\$ 87,319) to an NGO named International Orthodox Christian Charities (IOCC) for the provision of medical equipment under the scheme called Grant Assistance for Grass-roots Human Security Projects (GGP).

A Grant Contract was signed on February 4th, 2019 by H.E. Mr. Hidenao Yanagi, Ambassador of Japan to the Hashemite Kingdom of Jordan and Mrs. Loren Hyatt, the Country Representative of IOCC, Jordan.

This grant assistance aims to improve the quality of medical services provided at IOCC's hearing and visual clinic in Azraq refugee camp, through the provision of medical equipment to conduct hearing and eyesight test. In addition, a van to transport patients inside the camp will also be provided with the grant. IOCC started its operation in Jordan in 2005 and has implemented long-term development and resilience activities for vulnerable Jordanians, as well as humanitarian programs in response to influxes of Syrian refugees. Since 2017, IOCC has been supporting Syrian refugees with disabilities in Azarq camp by providing needed hearing and visual diagnosis services. With the new medical equipment provided by Japan, more accurate and immediate diagnosis and the required treatment afterwards will be available in the camp.

At the signing ceremony, Ambassador Yanagi expressed his gratitude to IOCC's great contribution to the society and stated: "Japan regards Universal Health Coverage as one of the important goals for Japanese Development Assistance. From that point of view, Health sector is one of the priorities for Japanese Assistance to Jordan. In this connection, we highly appreciate the activities of IOCC."

A Japanese Grant of US\$ 60,779 for the Project for Renewal of Kitchen Equipment to Support Income Generation for Women from Low Income Families

The Government of Japan has decided to extend a grant of sixty thousand seven hundred and seventy-nine US dollars (US\$ 60,779) to an NGO named Circassian Charity Association Woman's Branch (CCA) for the provision of kitchen equipment under the scheme called Grant Assistance for Grass-roots Human Security Projects (GGP).

A Grant Contract was signed on March 4th, 2019 by H.E. Mr. Hidenao Yanagi, Ambassador of Japan to the Hashemite Kingdom of Jordan and Mrs. Sura Khawaj, President of CCA.

This grant assistance aims to provide more job training and working opportunities mainly for the women from low income families through the renewal of kitchen equipment at "Samawer" kitchen. Since its establishment in 1971, CCA has worked towards empowering Jordanian women by providing them with access to employment opportunities. Through the development of CCA's activities, "Samawer" kitchen was established in 1998 and initially offered employment to 4 low income women. It has substantially grown through the support of the Embassy of Japan and now enables to employ 66 staff. With the new kitchen equipment provided by Japan, more job training and working opportunities will be provided at the "Samawer" kitchen.

At the signing ceremony, Ambassador Yanagi expressed his gratitude to CCA's great contribution to the society and stated: "The Government of Japan placed great value on the work of CCA, because this project aims to provide more vocational training and job opportunities mainly for women from low income families through the renewal of kitchen equipment. The empowerment of women is an important goal for Japan."
